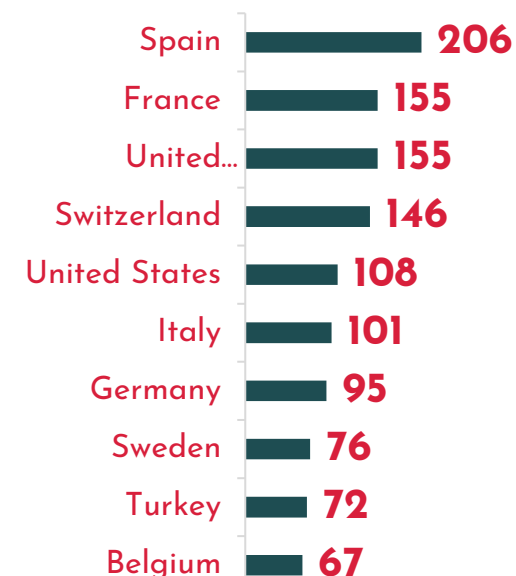

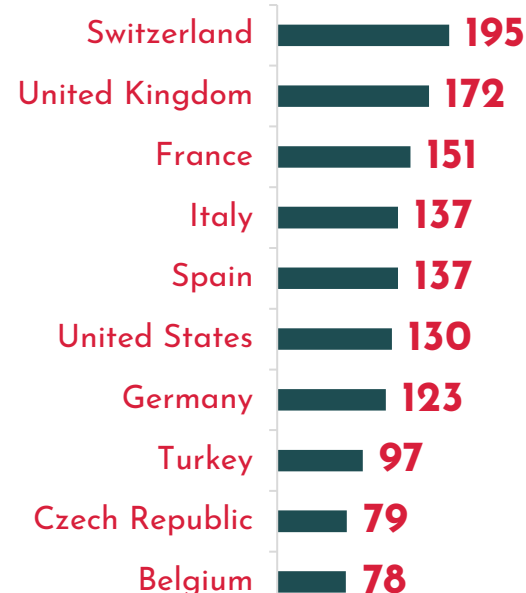
### Madrid 2018

Total registrations: 2'076



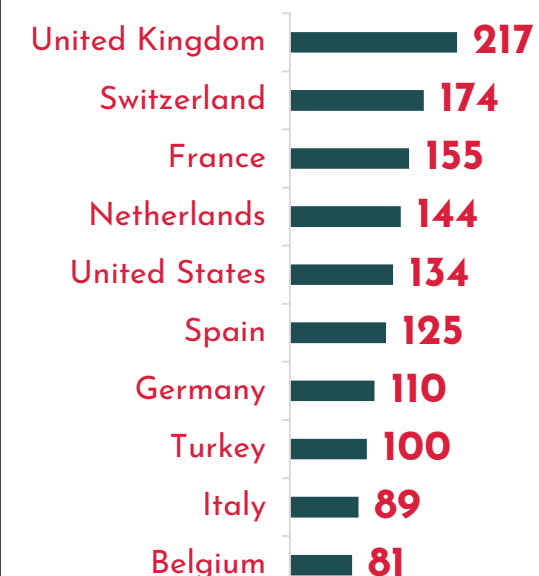
### Prague 2019

Total registrations: 2'610



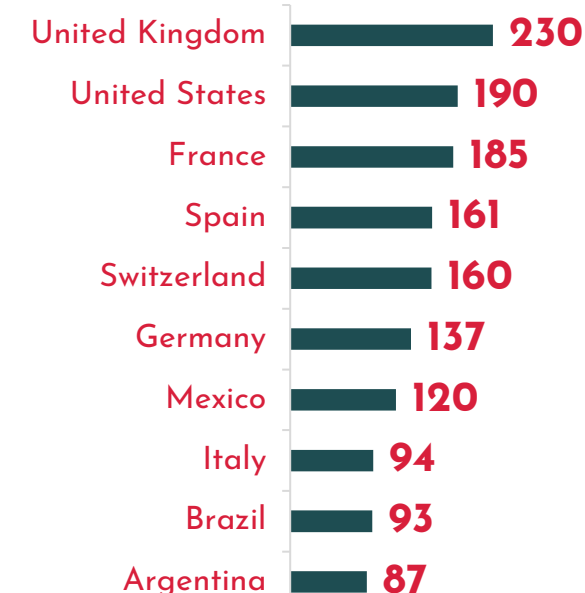
### The Hague 2020

Total registrations: 2'360



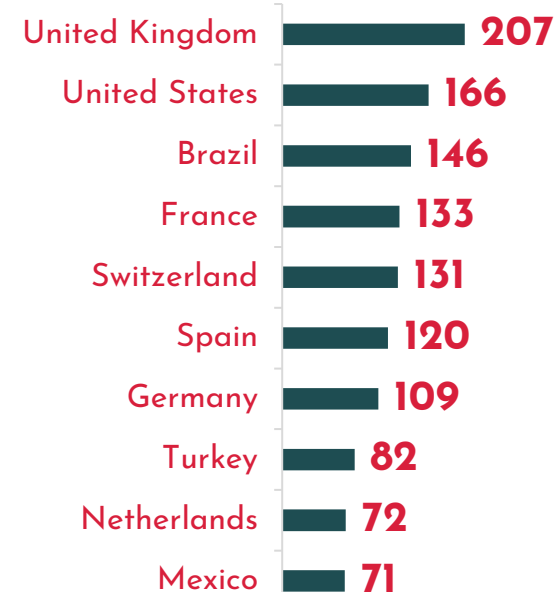

# Satellite Symposia

## General Guidelines

Symposia should have as their objective the communication of scientific material to enhance the knowledge of attending medical doctors, scientists, and other healthcare professionals.

A company may host a maximum of 1 symposium at EAHAD 2026. This includes a symposium organised by an external agency on behalf of a sponsor.

## Programme

Satellite Symposia should not replicate topics that appear on the main scientific programme. Please consult the EAHAD 2026 Scientific Programme available on the website.

The draft programme of the symposium must be sent to EAHAD by end October, the latest.

## Speakers

Individuals can appear (as lecturers/chairs/moderators/discussants) maximum twice. This includes the satellite symposia and the main programme sessions. Companies should ask their invitees to confirm that they are not appearing more than twice.

The EAHAD President and the Congress President will not accept invitations to appear on satellite symposia.

Individuals participating on the satellite symposia as speakers/chairs/discussants must register for the meeting as participants in the usual manner.

Satellite Symposia organisers must inform EAHAD in advance of any requests or unexpected changes regarding their Symposium (e.g. exclusion of delegates, streaming).

# Terms & Conditions

## Reservation

In order to be valid, your reservation must be completed via the official order forms. An invoice will be issued upon completion of your order, to be paid within 30 days of receipt.

The completion of an order constitutes a firm hire commitment and compels the subscriber to accept both the general conditions and the sponsorship rules and regulations. No verbal or telephone agreement will commit MCI Suisse SA nor the Organising Committee unless confirmed in writing. The full amount for your booking(s) must be received by 2 January 2026 at the latest. Non-payment by this stated deadline will lead to the cancellation of your booking, without reimbursement of the deposit paid. Satellite symposium slots and sponsorship items allocations will be attributed first to EAHAD Corporate Sponsors in order of reservation. Companies will be requested to make choices, but neither EAHAD nor MCI Suisse SA can guarantee first choice. Once locations have been attributed, no change of location will be possible without MCI Suisse SA's written agreement.

## Technical Manual

A Technical Manual will be sent to every registered sponsor by end November 2025 at the latest. This manual will contain all information regarding general conditions, safety regulations, arrangement conditions, specification documents and maps along with order forms and prices for furniture, decoration and all necessary services.

## Local and Site Regulations

## Insurance
